### 2§ Feedback and information:

- Malmö University's self evaluation: in collaboration with the Malmö Student Union and the
  Odontological Student Union the DSU have realized a student input on Mau's self evaluation on their
  work regarding broadening recruitment and participation. The main input that we gave from the DSU
  concerned the lack of inclusion of the international doctoral students, such as deficiencies in information
  and translation of important documents.
- **Two presentations** about the Malmö DSU and our work has been given, one in the supervisory education course (by Elsa) and one at the introduction for new PhD students (by Elsa and Roel).
- The DSU international chapter has been invited to give input on the information directed at international PhD students. Isobel, Nada and Julie will join a meeting with the information department and give their input on the HR website directed at international PhD students.
- <u>Doctoral ombud:</u> Elsa has a meeting planned with Christian Stråhlman and Klara Dryselius who is the president of the Student Union in Kristianstad. The meeting concerns cooperation possibilities regarding a doctoral ombud.
